It has been agreed upon by the Laborers' District Council that the one dollar (\$1.50) fifty cents increase for Interior Finish (PHILADELPHIA COUNTY) shall be applied as follows: twenty-five (\$0.25) cents increase into the Annuity Fund and one dollar twenty-five (\$1.25) cents increase into the Wage Rate.

Deductions from the wages will be as follows: five (\$0.05) cents increase into the P.A.C. Fund and five (\$0.05) cents increase into the Field Dues will remain the same.
